CLARIFICATION Nº 3

Project: CABO VERDE STATE OWNED ENTERPRISES RELATED FISCAL MANAGEMENT PROJECT

RFQ No: 033-SOE-UGPE - REQUEST FOR QUOTATION SUPPLY, ACTUALIZATION AND DENSIFICATION OF THE PERMANENT GNSS STATIONS NETWORK IN CABO VERDE.

Q50: In the answer A.7 from CLARIFICATION Nº 1 document, you mention that the existing stations have a Trimble Radio TDL 450H. Do you intend to keep using a radio on these sites, even though the stations will be equipped with a new router? If yes, what type of upgrade you foresee for the Trimble Radio TDL 450H? Please specify.

A50: Considering that we are going to install routers in each station, it will not be necessary to use the radio, so updating it is unnecessary.

<u>Q51:</u> In the answers A.12 and A.15 you mention the entity "Antennas Management". Please specify who is the entity 'Antennas Management'? Please confirm that this entity is the Purchaser as mentioned in the RFQ document.

A51: The entity responsible for the management (National Institute for Territory Management).

<u>Q52: In the answer A.14, you mention that you need a new server. Does that mean a new server should be part</u> of the Bidder's offer? If yes, please define the technical specifications of the desired server.

A52: #A server with the following characteristics (Windows Server 16, 16 GB Ram, 250 GB and 8 core CPU)

Q53: In the answer A.24, you mention that for the two new stations a structure for fixing can be proposed. Does that mean that it is part of the bidder's responsibility to propose the fixing structure as for example, antenna mast and mounting? Who will bear the costs for cost of manufacturing and installation of the mast? Do you expect it to be part of the Bidders offer?

A53: #Yes, it is the bidder's responsibility to propose the structural fixture for the two new antennas and the costs must be supported by the firm.

Q54: In the answer A.28, you mention the entity responsible for the Management. Who is this entity responsible for the Management? Please confirm that the mentioned entity belongs to the Purchaser as mentioned in the <u>RFQ document.</u>

A54: The initial costs (installation) should be covered by the firm, once everything is installed the costs will be covered by the entity responsible for the management (National Institute for Territory Management).
