Assignment Title: Technical Assistance to support the National Utility Regulator, ARME, (Agencia Reguladora Multisectorial da Economia) to implement its tariff methodology trough the cost of service study focused on tariff categorization.

- 1. The Government of Cabo Verde has received a financing for equivalent from the World Bank toward the cost of the Cabo Verde Renewable Energy and Improved Utility Performance Project, and it intends to apply part of the proceeds for consulting services. The objective of the Project is to increase renewable energy generation and improve the performance of the electricity utility in Cabo Verde by leveraging private finance. The UGPE intends to apply part of the proceed for consulting services: Technical Assistance to support the National Utility Regulator, ARME, (Agencia Reguladora Multisectorial da Economia) to implement its tariff methodology trough the cost of service study focused on tariff categorization.
- 2. The consulting Services ("the Services") refers to recruitment of a Consulting Service (a firm) to support the National Utility Regulator, ARME, to implement its tariff methodology trough the cost of service study focused on tariff categorization. The scope of work is to determine the Cost of Service for each activity (Generation/Acquisition, Transmission and Distribution/Sale segments of electricity) applying the tariff methodology approved by ARME. The assignment is expected to be fully executed during a 6 month period. All work must be completed within this timeframe.

- **4.** The implementing agency Unidade de Gestão de Projectos Especias (UGPE), now invites eligible Consulting firms ("Consultant") to express their interest in providing this service. Interested Consultants must provide information demonstrating that they are required qualification and relevant experience to perform the services.

Relevant material <u>must</u> not exceed 30 pages overall.

- **5.** The Selection Criteria are:
 - Core business and years in the related business;
 - Relevant Consultant's experience for this assignment
 - Experience with similar assignment in archipelagic nations will be considered an asset;
 - Technical and managerial organization of the firm;
- **6.** Key Experts will not be evaluated at this stage.
- **7.** The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers", dated July 2016 and revised in November 2020("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.
- **8.** Consultants may associate with other firms to enhance their qualifications but should indicate clearly in the letter of submission of EOI whether the association is in the form of a joint venture or as sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
- **9.** A Consultant will be selected in accordance with the **Consultant Qualification Selection** (**CQS**) method set out in the World Bank's "Procurement Regulations for IPF Borrowers", dated July 2016 and revised in November 2020.
