QUESTION 5.

Under Section III - 4.2 a Specific Experience. Are you looking for 3 contracts above 2 MUSD and 2 MWp, or are you looking for 3 contracts above 2 MUSD and 3 contracts of 2 MWp?

ANSWER 5.

The Applicant shall provide at least 3 contracts each with a minimum value of MUSD 2. The contracts can include but not necessarily the key activities, specified in the criteria requirements, for a minimum power of two (2) MWp.

Should the conditions cited above cannot be met, the Applicant shall provide at least one (1), two (2), or three (3) other contracts that demonstrate the key activities specified in the criteria requirements, for a minimum power of two (2) MWp.

QUESTION 6.

Is there a minimum number of contracts to meet criteria Section III - 4.2 b Specific Experience?

ANSWER 6.

At least three (3). That can be the same contracts as point 4.2a or other.
