Assignment Title: Technical Assistance for the elaboration and validation of the curricular programs for 12th grade and elaboration textbooks, guides, audio and interactive resources in key subjects for grades 10, 11, and 12

- 1. The Government of Cabo Verde has received from the International Development Association IDA / World Bank (hereafter named "World Bank"), the Credit ref. 70780 to fund the Cabo Verde Human Capital Project aims to assist the Ministry of Education in the management and coordination of the implementation of the National Plan for Teacher Training Horizon 2020/30, and intends to apply part of the amount of said credit for: Technical Assistance for the elaboration and validation of the curricular programs for 12th grade and elaboration textbooks, guides, audio and interactive resources in key subjects for grades 10, 11, and 12.
- 2. The Consulting Services ("the Services") aims to provide technical assistance to the Ministry of Education of the Republic of Cabo Verde in the drafting and scientific and pedagogical validation of the 12th grade secondary school programs and in the drafting and editing of the new school materials (student handbook, teacher's guide and audio and interactive resources) for the 10th, 11th and 12th grades of secondary education.
  - The services are to be provided by a specialized firm, working under the direct supervision of the National Directorate for Education (DNE). The duration of the contract/AT will be 3 (three) years. Its renewal will depend on a positive evaluation by the beneficiary (Ministry of Education) of the teaching materials produced for the first package. For each package of didactic materials (programs, manuals, and audio and interactive materials) prepared, there will be a experimentation/testing phase and a delivery of the final version.

  - **iii.** Relevant experience for this assignment demonstrating experience in the area of elaboration and edition curricular programs and didactic materials (textbooks, guides, audio and interactive resources) for secondary education;
  - iv. Specific experience in countries with similar conditions or context of Cabo Verde;
  - v. The technical and managerial capability of the firm.
