Assignment Title: TA to support co-management initiatives in artisanal fishing communities, to continue empowering communities in the sustainable and inclusive management of their marine and coastal resources

The Government of the Republic of Cabo Verde has received from the International Development Association – IDA/ World Bank (hereafter named “World Bank”), a Credit (hereinafter called “Credit”) toward the costs of the **Resilient Tourism and Blue Economy Development in Cabo Verde Project** and intends to apply part of the proceeds for consulting services. The objective of the Project is to increase diversity and resiliency in the tourism offering and SME participation in tourism-related value chains in targeted destinations.

- *Relevant Consultant's experience for this assignment;*
- *Specific experience in Cabo Verde or in countries with similar conditions or context of Cabo Verde;*
- *Technical and managerial organization of the firm.*

In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
