Assignment Title: Study on opportunities for solar energy solutions in coastal infrastructure.

The Government of the Republic of Cabo Verde has received from the International Development Association – IDA/ World Bank (hereafter named “World Bank”), a Credit (hereinafter called “Credit”) toward the costs of the **Resilient Tourism and Blue Economy Development in Cabo Verde Project** and intends to apply part of the proceeds for consulting services. The objective of the Project is to increase diversity and resiliency in the tourism offering and SME participation in tourism-related value chains in targeted destinations.

The objective of this Consulting Service (“the Service”) – aims to undertake a feasibility study of solar energy and energy efficiency opportunities in select coastal infrastructure, by identifying energy saving opportunities and where feasible, assessing specific energy requirements and proposing sustainable solar solutions.

 - *Technical and managerial organization of the firm.*

9. Consultants may associate with other firms to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
10. A consultant will be selected under the **Consultant Qualification Selection (CQS)** method set out in the World Bank’s “Procurement Regulations for IPF Borrowers”, dated November 2020.
