ASSIGNMENT TITLE: Recruitment Of A International Aviation Expert For The Preparation Of Regulatory Framework For The Civil Aviation Sector Of Cabo Verde

1. The Government of the Republic of Cape Verde has received from the International Development Association - IDA/World Bank (hereinafter referred to as the "World Bank") an advance for the Project Preparation (PPA) fund for the Improving Connectivity and Urban Infrastructure in Cape Verde Project. The Project aims to improve access for selected communities in Cape Verde through climate-resilient urban and transport infrastructure.
2. The government intends to use part of the funds to hire a International Aviation Expert for the preparation of regulatory framework for the Civil Aviation Sector of Cabo Verde. The consultancy should develop technical proposals in terms of regulatory framework to improve the civil aviation administration regulations, making the air transport sector of Cabo Verde more attractive, competitive and resilient. The deliverables should be based on international best practices and the recommendations of the study on the regulatory framework for Cabo Verde, supported by the World Bank Group, and executed by iOS Partners in July 2021, titled “ Assessment of Cabo Verde’s Civil Aviation Legal Framework”.

 - Strong evidence of project management achievement in the civil aviation sector;
 - Experience in developing and implementing a national civil aviation policy and legal framework;
 - Experience in effectively communicating with a variety of audiences on an international basis, in cultivating productive relationships, and handling sensitive national aviation policy situations with diplomacy and tact;
 - Experience in the provision of aviation policy-related assistance and support to State authorities, airports, airlines, etc;
 - Be able to work well in a multicultural team;
