FRUIT GROWING OR GARDENING.

- 1. The Government of Cape Verde (GOVCV) has requested funding from the African Bank to prepare and implement the Cape Verde Technology Park Project Phase II (PTCV II), as part of the Government of Cape Verde's strategy for the ICT sector and the Strategic Program for the Information Society (PESI), which aims to promote innovation and business development, serving as a lever for the country's growth. It also aims to boost the ICT sector, positioning Cape Verde as an international services center and as a "gateway to Africa" for the sector's major international companies.
- 2. The objective of this Consulting Services ("the Services") is to is to carry out, plan and promote gardening activities in the green spaces of the technology park, mainly fruit trees, with different tasks ranging from preparing the seedbed and nursery, adopting practices, fertilizing, preventing and controlling the main diseases associated with different species, in order to guarantee the good production and maintenance of the green spaces.

- In addition, the park has a wastewater treatment system and the consultant must assist the park management in installing irrigation systems and expanding the system already in place.

 - Ability to design, plan, implement and monitor similar projects that include plant production
 - Experience in gardening projects;
 - Proven experience in analyzing and interpreting data and preparing specialist reports;;

 - Ability to work in a multi-sector context and communicate effectively with specialists in other fields;
 - Fluency in spoken and written Portuguese;
 - Willingness to travel if necessary;
