**Assignment Title:** Technical Assistance to Implement a Business Enabling Environment:

Startup-Friendly Laws, Regulations and Policies Program

- 1. The Government of the Republic of Cabo Verde has received from the International Development Association (hereafter named "World Bank"), the Credit ref. 6792-CV to fund the **Digital Cabo Verde Project**, aiming to contribute to transforming the country into a regional digital hub for accelerating its digital economy through enhanced digital infrastructure and strengthened demand for digital services and skills, and intends to apply part of the proceeds for consulting services.
- 2. The purpose of this Technical Assistance is to assist the Ministry of Digital Economy (Ministério da Economia Digital MED in Portuguese) the Client, and the Special Projects Management Unit (Unidade de Gestão de Projetos Especiais UGPE in Portuguese) of the DCV Project, in designing, implementing and managing a Startup-Friendly Laws, Regulations & Policies project to foster the creation of digital businesses in Cape Verde through a more conducive regulatory environment in the country.
- 3. The assignment is expected to take about 6 (six) months from the date of signing the contract.
- 4. - 5. The implementing agency, Unidade de Gestão de Projectos Especiais UGPE, now invites eligible consulting firms ("Consultants") to indicate their interest in providing the services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. (Relevant material must not exceed 30 pages overall).
- 6. The shortlisting criteria are:
  - Core business and years in the related business;
  - Relevant experience for this assignment;
  - Specific experience in countries with similar conditions or contexts of Cabo Verde.
- 7. Key Experts will not be evaluated at the shortlisting stage.
- 8. The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers", dated July 2016 and revised in September 2023 ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.
- 9. Consultants may associate with other firms to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture and/or a subconsultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
- 10. A consultant will be selected under the **Consultants' Qualifications Selection (CQS)** method set out in the World Bank's "Procurement Regulations for IPF Borrowers", dated July 2016 and revised in September 2023.
