ASSIGNMENT TITLE: Collection of aerophotogrammetric data and base cartography drawing of the main urban centers of Cabo Verde.

Question nº 1: Is it permitted for a Consulting Firm to appear in two different EOIs

a. in both cases as a subcontractor?

Answer no 1.a. – Yes

b. as a member of a JV in one case and as a subcontractor in the second case? **Answer nº 1.b. -** No

Question nº 2: When you will evaluate the qualifications and experience of consultants, will you consider equally (with the same weight) consulting firms who associated themselves with others as a sub-consultant or as a member of a JV?

Answer nº 2: Joint ventures are a way of improving your qualifications and capabilities. The qualifications and experience of the consultants will be considered as a whole, as opposed to sub consulting, where only the qualifications and experience of the lead company are evaluated.

Question nº 3: The deadline for the delivery of the EOI is Sep. 9, 2024 at 23:59?

Answer no 3: That is correct.

Question nº 4: What is the maximum budget set aside for this assignment?

Answer nº 4: Please note that information on the budget is not available.

Question nº 5: 24 cities and 19 villages totaling 530 km² need to be mapped. Though it is not explicitly stated whether you expect an aerial survey with an aircraft and a large format camera or a survey with a drone and a small format camera, we noted that the word 'drone' appears twice in the TDR while there is no mention of an aircraft. However, we believe that, considering the size of the project, the use of an aircraft is fully justified, will allow a faster data capture and
