## Assignment Title: Upgrade of city's museum – São Vicente (ELABORAÇÃO DO PROJETO MUSEUGRÁFICO DO MUSEU DO MAR - MMAR ILHA DE SÃO VICENTE – CABO VERDE)

- 1- The Government of the Republic of Cabo Verde has received from the International Development Association – IDA/ World Bank (hereafter named "World Bank"), a Credit (hereinafter called "Credit") toward the costs of the Resilient Tourism and Blue Economy Development in Cabo Verde Project and intends to apply part of the proceeds for consulting services.
