The Government of the Republic of Cape Verde has received from the International Development Association - IDA/World Bank (hereinafter referred to as the "World Bank") a credit to fund the Improving Connectivity and Urban Infrastructure in Cape Verde Project. The Project aims to improve access for selected communities in Cape Verde through climate-resilient urban and transport infrastructure.
2. The general objective of this Consulting Service ("the Service") is to develop a secure and scalable aeronautical and maritime occurrence notification multi-platform system for Cabo Verde's civil aviation and maritime authorities.
