qualifications and relevant experience to perform the Service. (Relevant material must not exceed 30 pages overall).

5. The shortlisting criteria are:
 - *Core business and number of years in related business;*
 - *Relevant experience, demonstrated by a portfolio of similar assignments accomplished;*
 - *Technical and managerial capability.*
6. Key Experts will not be evaluated at the shortlisting stage.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank’s “Procurement Regulations for IPF Borrowers”, dated July 2016 and revised in September 2023 (“Procurement Regulations”), setting forth the World Bank’s policy on conflict of interest published on the World Bank website.
8. Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
9. Consultants will be selected in accordance with the method **Quality and Cost-Based Selection (QCBS)** set out in the World Bank’s “Procurement Regulations for IPF Borrowers”, July 2016 edition and revised in September 2023.
