**QUESTION 20: Site Preparation** 

Regarding to the site preparation of MRI system, there is only one article mentioned in the tender document, as "Prepare the pre-installation magnetic field protection study for the room where the magnetic resonance imaging will be installed and the magnetic field survey study after the equipment has been installed, as well as monitoring during the adaptation of the facilities."

Due to the importance of construction quality of magnetic shield, we would like to strongly suggest that the bidder should design and complete the preparation and decoration of magnetic shield room according to the site drawing provided by purchaser.

**ANSWER N° 20:** Bidder's is responsible for the design of the assembly and decoration of the magnetic shielding room in full compliance with the technical requirements necessary for the installation of the MRI system.

#### QUESTION 21: Proprietary Technology of a Specific Manufacturer

There are a lot of Siemens technology names in the technical specification requirements, such as DryCool, BLADE, DarkFluid, SliceAdjust, etc.. That means the Siemens Group has unjustified privilege and the other manufacturers will be eliminated from this tender, even if other manufacturers can provide equal or even better technology.
