The Government of Cabo Verde has received a financing in the amount of US\$ 29.00 million from the World Bank toward the cost of the *Health Security Program in Western and Central Africa Project*, and it intends to apply part of the proceeds toward payments under the contract for: *Purchase of an MRI scanner for Hospital Universitário Agostinho Neto (HUAN)*. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.
- 2. The Unidade Gestão de Projectos Especiais now invites sealed Bids from eligible Bidders for *Purchase of an MRI scanner for Hospital Universitário Agostinho Neto (HUAN)*.
- **3.** Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" dated November 2020 and revised in September 2023 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
