Assignment Title: Recruitment of an international consultant to carry out training in the area of meat inspection in the national slaughter system.

- 1. The Government of Cabo Verde has received a financing in the amount of US\$ 29.00 million from the World Bank Group's International Development Association (IDA) toward the cost of the Health Security Program in Western and Central Africa Project, and it intends to apply part of the proceeds toward payments under the contract for: Recruitment of an international consultant to carry out training in the area of meat inspection in the national slaughter system.
- 2. The consulting services ("the Services") is to hire an international consultant to strengthen national capacity in meat inspection to ensure compliance with national and international sanitary standards, protect public health, and support the safe trade of meat and meat products. This will be achieved through the training of 47 national technicians and inspectors (22 women and 25 men) on ante-mortem and post-mortem inspection procedures, hygienic slaughtering techniques, and sampling techniques for targeted pathogens and contaminants.

 - a) A minimum of a bachelor's degree in veterinary medicine (master's degree or specialization is an asset);
 - b) Significant experience of at least 10 years in the above-mentioned area;
 - c) Minimum of 10 years' experience in the area of sanitary inspection at slaughterhouse level and food processing plant;
 - d) Minimum of 10 years' experience as a trainer/teacher, with good knowledge of training methodology;
 - e) Oral and written proficiency in Portuguese.
