#### CLARIFICATION Nº 2

**Question Nº 3:** Subparagraph a) of point 3.2, “**Specific Objectives**”, of the Terms of Reference (ToR), establishes as a specific objective the strengthening of *“the competencies of primary education teachers, 1st and 2nd cycles, in subject-specific didactics, with a focus on the core disciplines, namely: Portuguese Language, Mathematics and Sciences in the 1st cycle, and Portuguese, Mathematics, Earth and Life Sciences, Physics and Chemistry in the 2nd cycle. This is to be achieved by equipping teachers with knowledge that contributes to the alignment of subject-specific methodologies with the improvement of teaching and learning processes, as well as through the production of a Pedagogical Handbook for each training module covered under this ToR”*. Nevertheless, it has been noted that **R4, under point 5, “Expected Results”, does not indicate a training course for 2nd cycle teachers in teaching methodologies for Earth and Life Sciences, Physics and Chemistry, nor the development of the corresponding Pedagogical Handbook**. Although this is included within the scope of the specific objectives of this technical assistance, we would be grateful for confirmation that the implementation of a course for 2nd cycle teachers in teaching methodologies for Earth and Life Sciences, Physics and Chemistry, including the development of the corresponding Pedagogical Handbook, is indeed not foreseen.

**Response Nº 3:** It is confirmed that the specific objectives are correct and that there is an omission in R4. It is missing/should be included: one (1) course for teachers of the 2nd cycle on teaching methodologies for Earth and Life Sciences and the design of the respective Teaching Materials (Caderno pedagógico) and one (1) course for teachers of the 2nd cycle on teaching methodologies for Physical-Chemistry and the design of the respective Teaching Materials (Caderno pedagógico).
