For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing

Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers, dated September 2025 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.

All envelopes marked “**FINANCIAL PART**” shall remain unopened and will be held in safe custody of the Employer until the second public Bid opening.
7. All Bids must be accompanied by a Bid Security, in a form of **Bank guarantee of 31 500 USD (Thirty-one thousand five hundred dollars)**.
